

**Settlement Benefits.** The Settlement provides up to \$10,000 to people who submit valid claims for out-of-pocket expenses, lost time relating to the Data Incident, and for two years of credit monitoring and identity protection services. The Settlement also provides an option for Settlement Class Members to submit a claim for an additional *pro rata* cash payment. Defendant also represents that they have adopted and implemented additional security measures following the Data Incident to further strengthen the security of their systems. **The only way to receive a benefit is to file a claim. To get a Claim Form, visit the Settlement Website, at [www.EmergeOrthoSettlement.com](http://www.EmergeOrthoSettlement.com), or call 1-844-979-3915. The claim deadline is June 24, 2024.**

**Opt Out.** If you do not want to be legally bound by the Settlement, you must exclude yourself. A more detailed notice is available to explain how to exclude yourself. You must mail your exclusion request, postmarked no later than **May 24, 2024**, to the Settlement Administrator. You cannot exclude yourself by phone or email. If you exclude yourself from the Settlement, you will receive no benefits under the Settlement and will not be legally bound by the Court's judgments related to the Settlement Class and Defendant in this class action.

**Object.** If you stay in the Settlement, you may object to it by **May 24, 2024**, if you do not agree with any part of it. A more detailed notice is available to explain how to object. You must mail your objection, postmarked no later than **May 24, 2024**, to the Settlement Administrator. You can object only if you stay in the Settlement Class.

**Other Options.** If you do nothing, you will remain in the Settlement Class, you will not be eligible for benefits, and you will be bound by the decisions of the Court and give up your rights to sue Defendant for the claims resolved by this Settlement.

On **June 11, 2024 at 9:30 a.m. ET**, the Court will hold a Final Approval Hearing to determine whether to approve the Settlement, Class Counsel's request for attorneys' fees not to exceed 33.33% of the Settlement Fund, or \$183,315.00, litigation costs not to exceed \$25,000.00 and for a Service Award Payment of \$5,000 to the Class Representative. You or your own lawyer, if you have one, may ask to appear and speak at the hearing at your own cost, but you do not have to. This is only a summary. # If You Were Notified by EmergeOrtho Regarding the May 2022 Data Incident, You May Be Eligible for Payment and Credit Monitoring Services from a Class Action Settlement.

A settlement has been reached in a class action lawsuit against EmergeOrtho, PA, (“EmergeOrtho” or “Defendant”) concerning an alleged data security incident affecting Defendant which occurred in or around May 2022 (the “Data Incident”). The computer systems possibly affected by the Data Incident potentially contained the Private Information of certain individuals. The Plaintiff claims that Defendant was responsible for the Data Incident. Defendant denies all of the claims.

**Who Is Included?** Defendant’s records show you received a notification from Defendant regarding the Data Incident, and, therefore, you are included in this Settlement as a “Settlement Class Member” unless you opt out of the Settlement.
